### Requirements for Inter-Institutional Agreements 2021-20[29]

**IMPORTANT INFORMATION:** For the next Erasmus programme, Inter-Institutional Agreements must be renewed using the new online Inter-Institutional Agreement Manager or an equivalent system connected to the Erasmus Without Paper Network. Therefore, this template is provided for information purposes only and must not be used to renew or create agreements outside of the new online system. This document gives a preview of the proposed format and content of the new online Inter-Institutional Agreement. When the Inter-Institutional Agreement Manager is released, it will be accompanied by a more detailed data standard, to which all equivalent systems will then need to adhere.

The institutions agree on exchanging their mobility related data in line with the technical standards of the European Student Card Initiative.
